West Springfield, MA – Massachusetts Package Stores Association (MassPack) President Benjamin Weiner announced at the February Board of Directors meeting that Robert A. Mellion, Esq. was unanimously elected to the position of Executive Director and General Counsel of MassPack.

Mr. Anzalotti stated, "The Board of Directors and I have hired Robert (Rob) Mellion as the Association's new Executive Director. Rob comes to MassPack with significant experience in association leadership and advocacy. He will do a great job. I wish to thank everyone."

Rob Mellion is a resident of Easton, Massachusetts. Rob is formerly the Chief Executive Officer/ President at the Bristol County Chamber of Commerce. He was also the Chamber's General Counsel. Mr. Mellion additionally served as Governor Charlie Baker's appointee to the Massachusetts Marketing Partnership and was the Chair of the Council of CEOs to the Massachusetts Association of Chamber of Commerce Executives (MACCE).

Mr. Mellion is an active attorney in Massachusetts and the U.S. District Court of Massachusetts. His law practice focus is business, economic development and government advocacy. A former member of the adjunct faculty at Bristol Community College he instructed Western Civilization and Business Law.

Prior to serving as President/CEO at the Bristol County Chamber of Commerce, Mr. Mellion was an entrepreneur and developer. Rob owned and operated a successful health club business and shopping center. He holds a Juris Doctor from UMass-Law, a Master's Degree from Providence College and earned his Bachelor's Degree in Political Science at the University of Nebraska – Lincoln.

Mr. Weiner commented "After a long search, we are delighted to have selected an outstanding candidate to succeed Frank, who has been incredibly important to MassPack. Mr. Mellion's diverse background as an association executive, advocate on Beacon Hill, entrepreneur, small business owner and attorney are ideally suited to our goals of pushing forward for our members.
